## BOARD OF GOVERNORS REGULAR MEMBERSHIP CONDITIONS AND REQUIREMENTS:

- Members shall be designated as Governors.
- Minimum age of 18 years is required for consideration of membership into the Committee of 300 of Long Beach, Inc.
- Members are required to wear approved official apparel at approved race-related promotions and events.
- Members are required to annually staff at a minimum of two (2) race promotional events sanctioned by the Grand Prix Association. One MUST be the annual Los Angeles Auto Show unless fully staffed.
- Members shall attend at least six (6) regularly scheduled Board of Governors meetings held on the 3<sup>rd</sup> Wednesday of each month.**
- Members are encouraged to actively participate in at least one (1) working sub-committee.
- Members are expected to conduct themselves in a manner consistent with the goals and objectives of the Committee of 300 of Long Beach, Inc. Individual representation is not permitted unless the member has been appointed to that capacity. While engaged in such activity members will refrain from any act which may bring discredit to the Committee of 300 of Long Beach, Inc.
- Members must fulfill the outlined requirements of the C300 before being credentialed to participate as a member in the Grand Prix of Long Beach Race Weekend. Two (2) grandstand tickets and necessary credentials will be issued to all members in good standing to facilitate the performance of assigned race weekend duties.
- Committee of 300 of Long Beach, Inc. members are encouraged to support official activities of the organization as well as Grand Prix of Long Beach Association related activities.
- All printed material, including membership roster information, is exclusive to the Committee of 300 of Long Beach, Inc. and shall not be used for any other purpose.
- Membership renewal is July 1<sup>st</sup> of each fiscal year. For returning members, dues are \$100. Membership is subject to review and approval by the Board of Directors.
- Regular Membership dues are as follows: July 1<sup>st</sup> – Dec 31<sup>st</sup> = \$150 (\$100 Membership, \$25 red shirt, \$25 one-time registration fee)  
Jan 1<sup>st</sup> – June 30<sup>th</sup> = \$100.00 (\$50 membership, \$25 red shirt, \$25 one-time registration fee)
- I understand and agree that my membership may be revoked if I fail to meet the above requirements, subject to procedures and guidelines contained in the Bylaws of the Committee of 300 of Long Beach, Inc. I agree to return all properties of the Committee of 300 of Long Beach, Inc. By payment of the annual dues, I accept the guidelines of membership.
- All members are required **to have fun** while participating with the Committee of 300 of Long Beach, Inc.
